- The ALPS | Stadion Tactical Growth Portfolio is an allocation strategy utilizing a proprietary Sharpe ratio analysis to select ETFs & tactically allocate among domestic, international, & non-correlated positions.

### Investment Management Process

#### ETF Rotation Utilizing a Three-Step Risk Management Process

#### 1 Research

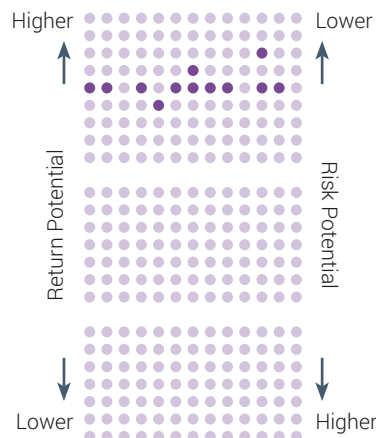
We continually rank the ETF universe using our proprietary Sharpe Ratio analysis. The Sharpe Ratio measures the excess return per unit of deviation, or risk, and our analysis provides a clear view of low-, medium-, and high-risk ETFs. We reduce individual stock risk by typically holding 8-15 ETFs, selecting sectors on a risk-adjusted basis.

$$\text{Sharpe Ratio} = \frac{\text{Average Return} - \text{Risk Free Rate}}{\text{Standard Deviation}}$$

*Standard Deviation is also known as historical volatility*

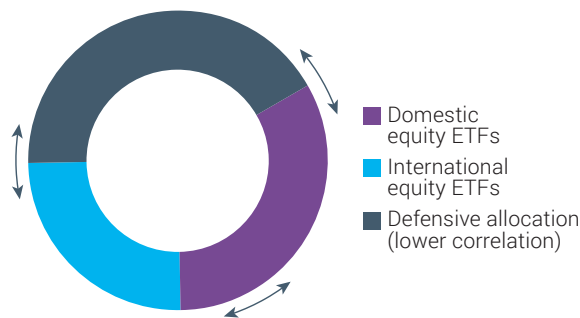
#### 2 Analysis

Our security selection process utilizes Sharpe Ratio analysis for domestic equity, international equity, and defensive holdings.



#### 3 Selection

As Sharpe Ratios change, the fund can reduce or increase its exposure to domestic equities.
